- Able to attend all synchronous e-learning session. Applicants will require an internet enabled device with a functioning webcam microphone and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English as the course is conducted fully in English without translation and in good health.

Objective

Conducted in collaboration with UNICEF, this course shares skill and knowledge on water management, urban sanitation, drinking water quality monitoring innovating financing and knowledge management.
