- Able to attend all synchronous e-learning session. Applicants will require an internet enabled device with functioning, webcam microphone and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English as the course is conducted fully in English without translation and in good health.

**Objective**

- This online course is conducted under the auspices of the SCP Training Awards.
- This course will provide Government officials, particularly non-lawyers and non-specialists, with an overview of how international investment treaty commitments apply to Governments.


