2 The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Mid to senior-level government officers (BS-17 and above) decision makers and policymakers involved in infrastructure planning nominated by respective governments.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with a functioning webcam, microphone and audio;
- Proficient in written and spoken English, and
- In good health

Objective

- This course is designed to help deliver on the UNEA sustainable infrastructure resolution by increasing the participants' understanding of opportunities and challenges associated developing sustainable infrastructure, as well as the policy conditions to enable and address them. The course will cover links between infrastructure and the sustainable development Goals (SDGs), with an emphasis on integrated approaches and how planners can maximize SDG outcomes by incorporating sustainability concerns into the early strategic planning of infrastructure. This knowledge can then be incorporated into decision-making processes.
