Eligibility Criteria.

- Government Officers (BS-17 and above) nominated by respective Federal Government or Provincial Department
- Must be Computer Literate
- Not be over 50 years old at the day of application
- Have at least 2 years of experience as health Personal
- Adequate proficiency in English speaking, reading, writing and listening.
- Be in good health both physically and mentally, and should have a health certificate provided by an authorized physician.

Objectives

- Explain concepts, principles and strategies related to community-based care in maternal and newborn health.
- Discuss with the core working group about the roles and responsibilities of community participation within their own setting
- Apply the knowledge and skill from the training course to develop project improving maternal and newborn health that appropriate with their country.

3. Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority alongwith following documents may be forwarded to this Division by 3rd April, 2020 (Friday) positively.
