
Program Objective

Eligibility Criteria:-

The applicant should:

- i. Participants must pass the regular admission procedures of GRIPS.
 - ii. Applicants for the scholarship program are requested to follow the two-way application process:-
 - a. **Application to the JICA Scholarship Program**
Applicants are requested to submit Essay (in 800-1000 words) covering major achievements in applicants' career, purpose and plan of study in Japan & career plan after Graduation alongwith application form.
 - b. **Application to GRIPS Admission Process**
Applicants are requested to access GRIPS Online Entry Form to fill and submit online application by 27 November 2020 (17:00 Japanese Standard Time) for MP1 and MP2 and by 13 January 2021 (17:00 Japanese Standard Time) for Doctoral Program, as instructed in Program Information.
 - iii. Proficient in spoken and written English
 - iv. Less than forty (40) years age in principle.
 - v. Have a Bachelor Degree for MP1 and MP2 and Master Degree for STI.
2. New prescribed JICA Application Forms along with job report and specimen of surety bond, undertaking and FTC Performa can be downloaded from EAD's website www.ead.gov.pk under "Foreign Trainings" link in "Forms" and also available on JICA's website www.jica.go.jp/pakistan/english/index.html.
3. In case of selection of the officer the concerned Ministries/Division/Department are requested to ensure timely relieving of the officer along with NoC.
