Course Objective:

Participants obtain skills and knowledge on planning and designing the electric power system to stably accommodate large amounts of VRE based on the understanding of the characteristics and challenges of VRE and electric power system

Eligibility Criteria:-

The applicants should:-

- Senior officers/engineers working for government ministries or agencies in charge of electric power distribution.
 - Have more than 5 years working experience in the field of electric power transmission, transformation or distribution.
 - Be a bachelor's degree in engineering or equivalent
 - Proficient in spoken and written English
 - Have basic computer skills.
 - Be between the age of thirty-five (35) and forty (40) years
 - Be in good health, both physically and mentally, to participate in the program in Japan.
