Eligibility Criteria

- Mid- to senior-level government officials who deal with public health-related issues in their course of work. A background in international law is not necessary;
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with a functioning webcam, microphone and audio;
- Nominated by their respective governments; and
- Proficient in written and spoken English.

Objective

- In our highly interconnected and globalized world, public health challenges must be dealt with on the international level. Economic globalization and liberalization have generated conflicting interests between health and international trade, investment and intellectual property rights. This course will share how global health law and governance can address these challenges.


