#### FUNCTIONS OF THE ECONOMIC AFFAIRS DIVISION

Economic Affairs Division (EAD) is responsible for assessment of requirements, programming and negotiations of external economic & technical assistance from foreign governments and multilateral agencies. It monitors and evaluates foreign economic assistance requirements in collaboration and consultation with the line Ministries/Divisions and provincial governments. EAD also manages external debt portfolio of the Government which includes its compilation, accounting and servicing of debt. For the purpose of having a policy dialogue with development partners and to present main elements of Government of Pakistan's priorities and future strategic directions, EAD hosts Development Forum (D-10) and Donor Coordination meetings. The organogram of EAD is at **Annex-I**.

EAD negotiates and arranges Foreign Economic Assistance (FEA) on concessional terms i.e. on low interest rates coupled with longer maturity period from Pakistan's bilateral and multilateral Development Partners (DPs) to finance the priority development projects of the Federal and Provincial Governments. EAD ensures that financial support from Development Partners is in line with priorities of the Government of Pakistan by articulating, prioritizing and monitoring the development assistance.

Pakistan has been receiving FEA from friendly countries and international development agencies under bilateral and multilateral arrangements. FEA is designed to foster growth through Balance of Payments support and is broadly categorized into (i) Grants (ii) Loans (iii) and Technical Assistance. Pakistan has traditionally been and continues to receive FEA to address it's needs to meet saving-investment gap and to improve social and economic indicators in pursuit of development objectives. Increasingly, FEA is linked to structural reforms in key economic sectors such as energy, taxation, banking and finance as well as reforms of the Public Sector Enterprises (PSEs) which contribute to economic growth. The main objectives of the assistance are to ensure the compatibility and convergence of foreign-assisted development activities with nationally determined priorities to accelerate the pace of economic and social development and to make positive contribution towards developing the country's infrastructural base. EAD is working to improve the quality, effectiveness and efficiency of FEA in achieving these development goals/objectives.

EAD acts as a coordinating agency and keeps close liaison with both Executing/Implementing Agencies and the Development Partners to ensure that development inputs are adequately sequenced for achieving desired development results as articulated in the national development strategy and vision. For this purpose, sectoral progress is monitored and periodic reviews are carried out with the DPs to assess the progress regarding implementation of projects under development assistance. Government of Pakistan and its development partners are committed to strengthen the partnership, based on mutual trust and shared accountability, to ensure effective management of FEA and delivery of the economic benefits of development assistance to the people of Pakistan.

## BILATERAL DEVELOPMENT PARTNERS

#### **CHINA**

Pakistan and China share a historic and strategic partnership, which has fostered and developed over the time. China is one of the most important and reliable DP of Pakistan. Pak-China Joint Economic Commission (JEC) was established in October 1982 with the purpose to review progress on bilateral protocols and agreements and explore possibilities of further strengthening development cooperation between the two sides. JEC is a high level ministerial forum led by EAD and the Chinese Ministry of Commerce (MOFCOM). It has met fourteen times so far.

The Asian Infrastructure Investment Bank (AIIB) was established on 25 December, 2015 with the aim to provide financing support to developing countries in Asia and Pacific for infrastructure development to promote regional connectivity. Memorandum of Understanding (MoU) for establishment of AIIB was signed by the Finance Minister on 24-10-2014 on behalf of the Government of Pakistan along with other Prospective Founding Members. Asian Infrastructure Investment Bank (AIIB) is a multilateral international bank established for financing support to developing countries for infrastructure development in order to promote regional connectivity in the Asia-Pacific region.

#### **CURRENT PORTFOLIO AND MAJOR ACHIEVEMENTS DURING FY 2017-18:**

#### a. China:

China is providing economic assistance to Pakistan under loans, grants and technical cooperation in the shape of trainings to Government officers. China is also providing assistance to Pakistan under the China-Pakistan Economic Corridor which is being carried out between the two countries as per MOU signed between the Governments of Pakistan & China on 5<sup>th</sup> July, 2013. The fields of cooperation under CPEC include connectivity through construction of Road & Railway Networks, Oil & Gas Pipelines, Fiber-Optics & Wireless Broadband Links between Western China and Pakistan, Industrial Park Construction/Economic Zones, Manufacturing and Energy Sectors; and strengthening of cooperation in Education, Culture, and Tourism & Media. China-Pakistan Economic Corridor is a collection of infrastructure projects that are currently under construction throughout Pakistan. This Division is involved in CPEC projects like KKH Phase-II (Thakot-Havellian), Peshawar Karachi Motorway, Orange Line, Construction of East Bay Expressway, New Gwadar International Airport Project, Gwadar Smart City Port Master Plan.

#### b. Asian Infrastructure Investment Bank (AIIB):

Pakistan has appointed the Finance Minister as the Governor and Secretary EAD as the Alternate Governor to the AIIB Board of Governors, while Joint Secretary, EAD holds the position of the Alternate Director of AIIB Board of Directors. The details of the ongoing 07 loan projects worth US\$ 6,764.5 million are at (**Annex-II**). There are 6 grant projects worth USD 302 million (approx) (**Annex-II-A**) which are at different stages of their completion. Moreover, 4 projects (3 loan and 1 grant projects) are completed (**Annex-II-B**). AIIB has financed its first project of US\$ 100 million in Pakistan (M-4 Motorway Shorkot-Khanewal Section). Second project of Tarbella-V extension project of US\$ 300 million was signed on 18<sup>th</sup> Jan 2017 (**Annex-II-C**). Ten loan projects are under negotiation with the Chinese authorities during financial year 2017-18. (**Annex-II-D**).

#### **Grant Agreements during FY 2017-18:**

Under the agreements on Economic and Technical Cooperation signed between Government of Pakistan and Government of PR of China, 1 project worth US\$ 0.89 million was completed. One project worth US\$ 4.4 million is on-going, five projects worth US\$ 277.94 million were signed and three projects worth US\$ 167.5 million are under negotiation with the Chinese authorities.

#### **Training Facilities under Technical Cooperation during 2017-18:**

China offered fully funded 121 training facilities including 8 mid-career master training programmes, 15 bilateral training programmes, 2 ministerial workshops and 97 multilateral/short term seminars for capacity building of public sector officials. More than 561 officers/technocrats from all over Pakistan availed this opportunity in various disciplines.

#### **JAPAN**

Japan and Pakistan established diplomatic relations on 28<sup>th</sup> April, 1952. Since then Japan has also become an important bilateral development partner of Pakistan with a substantial development assistance portfolio. Japanese technical assistance was initiated in 1954, however, Official Development Assistance (ODA), was started as loan in 1961 and grant in 1970. The various forms of assistance have contributed considerably in Pakistan's development over the years. Japan has remained one of the major sources of economic assistance, a leading trading partner as well as an important provider of foreign investment for Pakistan.

Japan's ODA comprises Yen Loans, Project Grants/ Non Project Grant Aid (NPGA) and Technical Cooperation. Loan assistance is extended on soft terms for basic economic, social and infrastructure projects, thereby providing support to government efforts for poverty reduction and economic growth. Grant aid supports development projects and social sector activities including health, education, water management etc. Under technical cooperation programme, Government of Japan extends assistance in the shape of expertise, equipment and trainings.

#### **Current Portfolio**

#### Yen Loans:

• Japan's current portfolio includes: 7 on-going projects with total loan assistance of JPY 85,772 million in the fields of Power, Roads, Irrigation and Health.

#### **Grants:**

• 11 Projects amounting to US\$ 158.86 million are ongoing in the fields of Education, Health, Water & Sanitation, and Energy.

#### Agreement signed during 2017-2018

#### a. Grant Assistance 2017-18:

Airport Security Improvement Phase 2 amounting to US\$ 22.70 million was signed on 27<sup>th</sup> March, 2018. Furthermore a non project grant agreement titled "The Economic & Social Development Programme" worth JPY 500 million was also signed on 27<sup>th</sup> March 2018 for the Pakistan Metrological Department.

#### b. Technical Cooperation:

Japan International Cooperation Agency (JICA) implements the Technical Cooperation Programme in Pakistan on behalf of the Government of Japan in the form of providing equipment, material, conducting feasibility/development/basic design studies, providing

technical expertise, and conducting training of Pakistani officials in Japan. Presently, 21 Technical Cooperation Projects are being implemented.

In addition, JICA offered 78 slots during 2017-18 for various short/long training courses for Government Officials. Number of Country Focused Training Programmes for Pakistan has also been increased by JICA from two to four for the year 2017-18.

#### c. Request Survey for Technical Cooperation Projects for Japanese Fiscal Year 2018:

Under the Government of Japan's Request Survey for implementation of projects under Technical Cooperation Programme for Japanese fiscal year 2018, five projects were considered under Category A (approved status) by Government of Japan and are currently under the process of implementation.

#### d. Pakistan – Japan High Level Economic Policy Dialogue 2018:

Fifth Pak-Japan Economic Policy Dialogue was held on April 26, 2018 after a gap of 7 years. During the Policy Dialogue matters like revision of Travel Advisory, facilitation to businessmen, enhancement of trade in IT, Textile and Agriculture sectors were discussed. Efforts to strengthen government's administrative capacities in the country, through providing opportunities to obtain Masters / PhD degrees to the government officials will be further explored.

#### PARIS CLUB (PC)

#### **United Kingdom (UK):**

UK has a sizable development assistance programme in Pakistan. The total amount of development assistance provided by UK in the form of grant in financial year 2017-18 stood at £ 674.7 million, including bilateral, multilateral and humanitarian assistance. UK provides grant assistance to Pakistan for Education, Health, Nutrition, Poverty Reduction, Stability & Growth, Humanitarian, Financial Inclusion and Skill Development, assistance for Benazir Income Support Program (BISP), Pakistan Poverty Alleviation Fund (PPAF) and State Bank of Pakistan (SBP) etc.

#### **Instruments of Cooperation:**

The basis of relationship with the UK is the MOU signed in 1992 between the Governments of Pakistan and United Kingdom. Pakistan and UK entered into a long-term development assistance relationship in 2006 through the 10 year Development Partnership Arrangement (DPA). DPA reaffirmed the partnership between the two sides and laid down a joint vision to:

- Reduce poverty and achieve MDG's;
- Strengthen financial management and accountability;
- Respect international human rights obligations; and,
- Improve coordination between donors;

The current draft Development Partnership Arrangement (DPA) (which is awaiting approval from the UK) is based on the following three pillars:

- Achievement of the Millennium Development Goals;
- Respect for human rights and other international obligations; and,
- Commitment to public financial management, promoting good governance and transparency and fighting corruption;

#### **Overview of the Portfolio:**

Currently, the UK has 7 on-going on-budget projects. UK portfolio for Pakistan is £ 674.7 million in 2017-18 out of which, DFID's Pakistan bilateral commitment stands at £ 400.82 million (60% of total aid), Multilateral Programme £ 209.16 million (31% of total aid), Centrally Managed Programme £ 40.48 million (6% of total aid) and other Humanitarian Programs at £ 20.24 million (3% of total aid).

#### **UK's Activities during 2017-18:**

The following amendment to the Activity Agreements of UK funded on-budget grant project has been acknowledged/signed by EAD during 2017-18:

• Amendment No.3 of Provincial Health and Nutrition Programme (PHNP) worth £ 160 (US\$ 207.43 million) was signed on 19<sup>th</sup> July, 2017.

The Pakistan – United Kingdom Annual Bilateral Assistance Talks 2018 were held in Islamabad on 1<sup>st</sup> March, 2018.

#### **Future Areas of Cooperation:**

Civil Service Reforms, Tax Reforms, Population Growth Control, etc,

#### **Open Government Partnership (OGP):**

After intensive interaction with relevant stakeholders, EAD has finalized the National Action Plan (NAP) which is in the final stages of approval by the Federal Government.

#### Italy:

Republic of Italy has a long term development assistance programme in Pakistan. The total portfolio of development assistance provided by Italy in form of loans till 2017 stood at Euro 149 million including bilateral and humanitarian assistance. Italy has provided assistance to Pakistan in the priority areas i.e. Poverty Reduction and Rural Development, Technical and Vocational Training, Health, Education, Agriculture, Microfinance and Environment etc.

#### **Instruments of Cooperation:**

The basis of relationship with the Republic of Italy is the agreement signed in June 2001, on consolidation of Pakistan's debt. Governments of Pakistan and Italy signed a Joint Declaration on 14<sup>th</sup> July, 2005 for expansion of bilateral co-operation in the economic and commercial fields.

#### **Overview of the Portfolio:**

Currently, Italy has 1 on-going on-budget project and 4 Pipeline projects.

#### **Main Development Activities during 2017-18:**

#### **Pak-Italy 3<sup>rd</sup> Joint Economic Commission:**

The 3<sup>rd</sup> session of Pak-Italy Joint Economic Commission (JEC) was held on 29-30 January, 2018 in Rome, Italy. The Minister of State for Finance and Economic Affairs, Rana Muhammad Afzal Khan was Co-chair from Pakistan side and H.E. Ivan Scalfarotto, Deputy Minister for Economic Development was co-chair from the Italian side. The next session is proposed to be held in the first quarter of 2019.

#### **Future Areas of Cooperation:**

#### **Economic Transformation Initiative in Gilgit-Baltistan (ETI):**

Economic Transformation Initiative (ETI) is a program that aims to provide infrastructural support, capacity building and technical assistance to stakeholders in Gilgit Baltistan. Italian Government agreed to join hands with IFAD for providing a soft loan of Euro 20.5 million. The draft financing agreement is in final stages of processing.

#### **Switzerland:**

Switzerland has supported Pakistan through off-Budget interventions amounting to CHF 43 million (US\$ 42.94 million) till the year 2017. Switzerland provides assistance for Poverty alleviation, empowering people by improving good governance and livelihoods and supporting disadvantaged population groups.

#### **Instruments of Cooperation:**

The basis of donor relationship is the agreement signed in 1966 on Technical & Scientific Cooperation.

#### **Pak-Swiss Annual Bilateral Consultation (ABC):**

Pak-Swiss Annual Bilateral Consultation was held in February, 2018. The next ABC is proposed to be held in Islamabad February/March 2019.

#### Overview of the Portfolio:

Currently, Switzerland provides aid to Pakistan through off-budget channels.

#### Spain:

Development Cooperation with Spain is currently dormant. As of now, there is only one project in the pipeline. Efforts are being made to reinvigorate cooperation between the two countries.

#### **European Union:**

European Union has a sizable development assistance programme in Pakistan. The total amount of development assistance provided by EU in the form of grant till the year 2017 stands at Euro 1.75 Billion including bilateral and humanitarian assistance. EU provides grant assistance for Rural Development, Natural Resource Management, and Education & Human Resource Development. Some of the non-focal areas of Pak-EU development cooperation are trade and economic cooperation, democracy, human rights, counter terrorism, security and humanitarian assistance.

#### **Instruments of Cooperation:**

The basis of donor relationship is the MoU signed in 1991 between the Commission of the European Communities and Pakistan. Another agreement entitled Cooperation Agreement was signed between Pakistan and European Community in 2004. Since 2014, EU and Pakistan have signed the Multi Indicative Programme (2014-2020).

#### **Overview of the Portfolio:**

Currently, the EU has 22 on-going Off-Budget projects and 4 On-Budget projects.

#### **Pakistan - EU Financing Agreements:**

In December 2018, Pakistan and EUD signed three financing agreements i.e. "Support to Parliamentary Development in Pakistan (Euro 15 M), Growth for Rural Advancement and Rural Sustainable Progress (Euro 50 M), and Development through Enhanced Education Programme, (Euro 50 M)".

#### **Current Activities:**

Both sides engage through various institutional arrangements including Programming Steering Committee meetings, Biannual Portfolio Review meetings and other engagements to discuss progress on on-going projects. Recently, the Mid Term Review of the current portfolio was also held.

**Programming Steering Committee (PSC)** – The PSC offers a major forum for portfolio review between the two sides. The last meeting was held on September 19, 2018.

**EU-Pakistan 9<sup>th</sup> Joint Commission** - Recently, the 9<sup>th</sup> Joint Commission between Pakistan and EU was held in Islamabad from 13 – 16 November, 2018. It served as a forum to discuss future areas of cooperation, recent economic and political developments in Pakistan and the EU and provided an opportunity to address outstanding issues. The next session is proposed to be held in Brussels in 2019.

#### **Future Areas of Cooperation:**

- Rehabilitation of people from FATA and Balochistan who are now being brought forward to ensure equal participation and inclusive growth in Pakistan.
- Cooperation in sectors of Human Resource Development through initiatives in Education and Skills Development as Pakistan has a youth bulge and the need to not only create jobs but ensure that young men and women are skilled and employable.
- Strengthening SME's to help them find a voice in competitive markets.

#### Germany:

Pakistan has been a recipient of German Development Assistance since the founding of German Federal Ministry for Economic Cooperation and Development (BMZ) in 1961. The two sides celebrated the 50<sup>th</sup> anniversary of development cooperation in 2011. The total development assistance encompassing both technical and financial cooperation since 1961 amounts to € 3.1 billion. The volume of development assistance and priority areas are identified through biennial negotiations between BMZ and Economic Affairs Division, held alternately in Berlin and Islamabad. The focus of development cooperation has largely been on KP, FATA and Punjab. Projects in other areas in the past pertain to Strengthening Civil Law Enforcement in Sindh, Rehabilitation of Vocational Training Centers in Quetta, Baluchistan Water Supply, Water and Sanitation Extension Program in Gilgit-Baltistan etc.

Assistance is focused on the following sectors:

- i. Good governance
- ii. Renewable energy and energy efficiency
- iii. Basic education/vocational training
- iv. Health

The German government stands committed to remaining engaged in cross-cutting issues such as gender equality, human rights, corruption and climate change. It also plans to continue support to multilateral organizations, German political foundations, NGOs and private-sector organizations working in these areas.

#### **Instrument of Cooperation:**

Bilateral Agreement on Technical Cooperation between Pakistan and Federal Republic of Germany, signed in 1972, forms the basis of bilateral cooperation.

#### **Overview of Portfolio:**

Currently, Germany has 19 on-budget and 18 off-budget projects.

The following Financing Agreements are in advanced stages of processing:

- Financial Cooperation 2016 Total Financial Assistance for €58.7 million (€26.8 million Loan and €31.9 million grant)
- Technical Cooperation 2017 Total Financial Assistance for €23 million
- Financial Cooperation 2017 Total Financial Assistance for €9,400,000.00

Government to Government (G2G) Consultations - The EAD recently, hosted a German delegation in Islamabad on November 22, 2018 for G2G Consultations. These are held as a preparatory measure to discuss future areas of cooperation, new ideas and proposals for the G2G Negotiations. EAD is currently preparing for the G2G Negotiations which are to be held in Berlin in 2019.

#### **Future Areas of Cooperation:**

- Support for vocational training in Pakistan as a vehicle for employment generation and poverty alleviation and its contribution to development of education and health sectors in Pakistan.
- Expanding engagement in industry, trade and investment as it is on the agenda of the current government to create more jobs.
- Investment in renewable energy; projects that not only address issues in the power sector but also help in making environment friendly choices.

#### Belgium:

Cooperation with Belgium is currently in dormant stages. However, efforts are being made to reinvigorate cooperation between the two countries.

#### France:

France, as a member of Aid to Pakistan Consortium, has been extending development assistance to Pakistan since 1961. The bilateral economic cooperation revived with the 2008 meeting of Friends of Democratic Pakistan. Cooperation with France is taking place under the "Joint Declaration on Economic and Commercial Partnership" signed in May 2011 between the Governments of Pakistan and France.

France carries out its development activities mostly through the French Development Agency (AFD). AFD is a public financial institution that implements the policy defined by the French government, and was founded in 1998. Government of Pakistan granted permission to AFD and its subsidiary PROPARCO, a development finance company for the private sector, to establish office in Pakistan on 02-12-2008.

#### **Overview of the Portfolio:**

An overview of AFD portfolio is as under:-

AFD has been involved in development activities in Pakistan since 2007. In 2018, the total portfolio of AFD funded projects amounted to Euro 788.35 million as soft loan, out of which €342.85 is reserved for ongoing and €445.5 million is for projects in the pipeline. There are a total of sixteen (16) projects (9 ongoing and 7 pipeline projects).

• The total disbursement under the AFD portfolio in 2017-2018 stood at € 48.07 million mainly in energy and power sectors.

#### **Instruments of Cooperation:**

Pakistan and France have upgraded the Administrative Economic and Trade Committee (AETC) to the level of the Joint Economic Commission (JEC). Its first meeting is expected to be held in France in April/May 2019.

#### **Future Area of Cooperation:**

AFD is currently supporting Pakistan mainly in Environment and Energy sectors. Potential areas for cooperation in future are the renewable Energy, Energy Efficiency, Urban Mobility and Sanitation sectors.

#### Russia:

Cooperation with Russia is taking place under the "Agreement between Pakistan and Russia on Trade and Economic Cooperation" signed in April 1999. Pakistan and Russia reviewed their bilateral development and trade cooperation and agreed to establish an Inter-Governmental Commission (IGC) on Trade, Economic, Scientific and Technical Cooperation in March, 2000.

#### **Instruments of Cooperation:**

- 5<sup>th</sup>session of Pak-Russia Inter Governmental Commission (IGC) on Trade, Economic,
   Scientific and Technical Cooperation was held on November 28-30, 2017 at Moscow,
   Russia.
- 6<sup>th</sup> Session of Pak-Russia Inter Governmental Commission (IGC) is proposed to be held last quarter of 2019 in Islamabad.

#### **Future Area of Cooperation:**

Potential areas for cooperation in future are Defense, Energy, Industries & Production, Trade & Investment, Transport & Logistics, Cyber Security, and Education & Professional Training.

#### Norway:

Norway Joined Pakistan Development Forum (PDF) in 1969 formally known as Aid to Pakistan Consortium and since then has been providing assistance to Pakistan.

#### Overview of the Portfolio:

Earlier, Pakistan and Norway worked together in the areas of Energy, Education, Environment, Telecommunication Sector and Human Rights. Now Norwegian Government provides assistance to GoP in areas of basic Education and Capacity Building only.

#### **Type of Non-Government Assistance:**

Norwegian Government provides grant assistance which is completely off-budget and disbursed through INGO's and UN agencies.

The Government of Pakistan, through Economic Affairs Division, signed a Grant Agreement, with total worth of NOK 217.6 million with the Government of Norway during the period 2003 to 2012 in areas as education and governance.

#### **Future Areas of Cooperation:**

 Norway has good expertise in hydropower and can extend cooperation to Pakistan in this sector.

#### Austria, Denmark, Netherlands and Sweden:

Development Cooperation with Austria, Denmark, Netherlands and Sweden is in dormant stages. However, efforts are being made to reinvigorate cooperation between these two countries.

#### **UNITED STATE (US)**

#### **United States of America (USA):**

United States of America (USA) is providing economic assistance principally through Economic Support Fund (ESF) for social sector development in Pakistan. ESF has been managed through different bilateral instruments signed with USA. These include the Strategic Objective Grant Agreement (SOGA) 2001, Pakistan Enhanced Partnership Agreement (PEPA) 2010, Unilateral (Cash Transfers to BISP, ERRA, Citizen Damage Compensation Program etc and International Narcotics and Law Enforcement – Pakistan 1982 (INL-P)

The USAID provides economic assistance in two modes i.e. On-budget (G2G) and Off-budget (Non G2G). On-budget assistance is provided through Government of Pakistan whereas Off-budget assistance is channeled through INGO's and Implementing Partners of the USAID which are mostly for-profit companies based in USA, and are selected independently. The ratio of G2G and Non G2G assistance has always remained tilted towards Non-G2G mode.

#### International Narcotics and Law Enforcement-Pakistan (INL-P):

The Embassy of the USA has been extending financing facility for continuation of projects like Drug Interdiction, Rule of Law, and Crop Control. For this, a Letter of Agreement (LoA) was signed with the International Narcotics and Law Enforcement-Pakistan (INL-P) in 1982. Till now, 78 revisions to the LoA have been signed wherein a total US\$ 817.6 million have been provided.

The portfolio of US Economic Assistance to Pakistan (on-budget projects, G2G) commitments currently stands at US\$ 1,902 million. Of this, US\$ 1,523 million are for on-going projects, whereas, US\$ 379 million are for pipeline projects. Regarding off-budget projects (non-G2G), the economic assistance stands at approximately US\$ 3,000 million.

#### **USA Activities / Achievements during the FY 2017-18:**

USAID's funded on-budget project "Strengthening of Health Services Academy Project" started in 2018 with a grant, amounting to US\$ 2.25 million. Fifteen amendments to the Activity Agreements/Project Implementation Letters and ten new Project Implementation Letters of USAID funded grant projects (on-budget) were acknowledged/ signed by EAD during the 2017-18. These amendments were either related to the extension of completion date or an addition to commitment of grants for different projects under PEPA.

During 2017-18, five (05) Project Implementation letters of INL-P were acknowledged/signed which were related to Firearms Simulators upgrades, Construction of Barracks for exclusive use by National Highways and Motorway Police female office, including recruits and in-service trainees, law enforcement, crop control and area development.

#### Programme of activities and target under process:

USAID/ INL-P, US Embassy has shared following documents that will be signed between USAID and EAD after fulfillment of all codal formalities.

- i. Amendment No.23 to Pakistan Enhanced Partnership Agreement (PEPA) to allocate additional funds of US\$ 182 million for the year 2017 to complete the on-going programme activities in Pakistan.
- ii. Amendment No. 24 to Pakistan Enhanced Partnership Agreement (PEPA) for no-cost extension from 30<sup>th</sup> September, 2020 to 30<sup>th</sup> September, 2023 to complete the on-going programme activities in Pakistan.
- iii. Draft of the Development Objective Grant Agreement (DOAG) is to align activities with USAID/Pakistan's new Country Development Cooperation Strategy (CDCS) for the next five years (2018-2023).
- iv. Amendment/Revision No. 79 of the Letter of Agreement, 1982 in which INL-P, US Embassy spells out their yearly program for on-going/pipeline projects.

For the future, the USA may provide assistance in the fields of energy including renewable energy, infrastructure, education and health. These will not only address Pakistan's energy supply problem but provide environment friendly solutions. INL-P may help in enhancing effectiveness and professionalism of civilian law enforcement entities to reinvigorate public confidence in these institutions and improve the adjudication of complex crimes, like terrorism.

#### Australia:

Pak-Australia bilateral development cooperation commenced with a Memorandum of Understanding on Development Cooperation signed in July 1991. The Australian Government committed to provide expertise in Mining and Mineral Exploration Technology, Telecommunication, Beef/Dairy Cattle/Agricultural Value Chains, Food Processing and Post Harvest Technology and Water Management

During 2017-18, Economic Affairs Division has issued NoCs for two of their technical assistance programs which are strengthening vegetable value chains in Pakistan for greater community livelihood benefits and strengthening vegetable value chains in Pakistan for greater community livelihood benefits.

In 2017-18, Australia offered nearly 40 Australia Awards Scholarships to Pakistani citizens, and at least half, for women. Fifty percent of these are reserved for public policy practitioners, reformers and leaders. Scholarship will also be awarded to professionals working in civil society and the private sector.

There are bright prospects of investment in Pakistan in mining and achieving proper energy mix through clean energy projects like hydel and clean coal. The Australian aid program may support provinces in delivery of critical services in education, nutrition and rural infrastructure.

#### **Global Affairs, Canada:**

The Government of Pakistan and the Government of Canada signed a MoU in April 2006 to convert Canadian debt amounting to C\$ 449.533 million into grant for enhancing capacity of teacher training institution and training of elementary school teachers across the country. Accordingly, Pakistan-Canada Debt for Education Conversion (Canadian Debt Swap Project) amounting to Rs. 6.984.00 million was launched. During 2017-18, an expenditure of 214 million has been written-off under the said program. So far an amount of Rs. 6,717 million has been written-off out of total cost of the project.

During 2017-18, Global Affairs, Canada has informed of their plans to introduce Canada's Feminist International Assistance Policy to increase bilateral International Developing Assistance from level of 2% to 15% related to general equality and the empowerment of women and girls by Year 2021-22. It is an off-budget program.

In the future, Canada may provide assistance to Pakistan in areas such as health and nutrition, education, sustainable agriculture, green technologies, renewable energy, environment and climate action focusing on adaptation and mitigation, as well as on water management, inclusive governance, including democracy, human rights, the rule of law and good governance.

### MULTILATERAL ORGANIZATIONS/ DEVELOPMENT PARTNERS

#### ASIAN DEVELOPMENT BANK (ADB)

#### **Relationship with Asian Development Bank:**

Asian Development Bank (ADB) is a multilateral development bank owned by 67 countries including 48 from Asia and the Pacific region and 19 from other parts of the world. ADB's main instruments for helping its developing member countries are policy dialogue, loans, equity investments, guarantees, grants, and technical assistance.

Pakistan is one of the founding members of the Asian Development Bank since 1966. ADB has since worked with the Government of Pakistan to strengthen the country's key infrastructure, social services, and economic growth. ADB helps address Pakistan's development needs for energy, transport, agriculture, natural resources, rural development, water supply, urban infrastructure & services, public sector management, and finance. ADB's cumulative disbursement stands at \$22.2 billion for Pakistan.

#### **Portfolio Performance:**

The total on-going portfolio of ADB amounts to US\$ 6.6 billion as of 30<sup>th</sup> June, 2018. The portfolio comprises of 39 active loans, 6 grants and 2 co-financing loans. In addition, 37 technical assistance projects amounting to US\$ 66.5 million are also under implementation. Major thrust of ADB's investments remained in Energy, Road & Transport, Irrigation and Financial Sectors across Pakistan. ADB disbursed an amount of US\$ 1.018 billion for on-going projects which is highest among all multilateral development partners.

#### **Major Events:**

- Pakistan participated in the 16<sup>th</sup> Central Asia Regional Economic Cooperation (CAREC) Ministerial Conference held in Dushanbe, Tajikistan on 27<sup>th</sup> October, 2017. The Ministerial Conference functions as a high-level strategy-setting and policy body. It provides overall strategic guidance and serves as a platform to discuss and debate important policy and strategic issues of regional relevance. At the 16<sup>th</sup> Ministerial Conference on CAREC in 2017, ministers endorsed CAREC 2030: Connecting the Region for Shared and Sustainable Development (CAREC 2030), the new strategic framework that will guide the Program over the next 13 years. CAREC 2030 builds on the solid foundation of progress made under CAREC 2020, while updating its strategic directions to respond more efficiently to the region's long-term development challenges.
- Pakistan attended the 51<sup>st</sup> Annual Meeting of the Board of Governors of Asian Development Bank, held on 3 6 May, 2018, in Manila, Philippines. The Pakistani delegation was led by the Secretary EAD / Alternate Governor ADB. The Annual Meeting is an opportunity to provide guidance on the administrative, financial, and operational directions of ADB. The meetings provide opportunities for member governments to interact with ADB staff; nongovernment organizations; media; and representatives of observer countries, international organizations, academe, and the private sector.

#### ISLAMIC DEVELOPMENT BANK (IDB)

#### **Islamic Development Bank (IDB):**

- IDB is an International Financial Institution, established in 1975 with the aim to foster economic development and social progress of 57 Muslim member countries in accordance with the principles of Shari'ah.
- IDB's total project portfolio during 2017-18 for Pakistan was US\$ 662.92 million, out of which an amount of US\$ 56.97million was disbursed by the IDB during 2017-18.
- The Member Country Partnership Strategy (MCPS) is a detailed document of IDB through which the strategic thrust of the IDB Vision 1440H (2020) was aligned with development priorities of the GOP. MCPS (2012-17) Group Strategy was developed based on extensive consultations with key stakeholders in Pakistan including Federal and Provincial Governments, private sector, business community and civil society. The resource envelope of US\$ 2.75 billion available under the strategy is distributed among three pillars i.e. the infrastructure sector envisaged to receive the majority share of 50% (energy 30% and transport 20%) followed by agriculture and rural development 20% and human development 15% (education 8% and health 7%). The allocated amount has been fully utilized by GOP during the period of 2013-17. The overall implementation of the MCPS is 137% (i.e. approval of US\$ 3.768 billion against US\$ 2.75 billion indicative financing by IDB Group. The next MCPS for the period of 2018-20 is expected for negotiation with IDB during the first quarter of year 2019.
- On the advice of Finance Division and initiative of State Bank of Pakistan, IDB was approached by the EAD in July, 2013, to provide a short term Commodity Murabaha Financing facility amounting to Euro 750 million for Budgetary Support, which was provided by IDB and fully utilized during the period 2013-15. On advice of Finance Division, another amount of US\$ 200 million (US\$ 100 million each) were received from IDB during the financial years 2016-17 and 2017-18.
- IDB has also conveyed concurrence for signing of agreement amounting to US\$ 35 million for CASA-1000 Project on energy sector. The project is being co-financed by ADB, IDB and GOP.

#### **International Islamic Trade Finance Corporation (ITFC):**

• ITFC, an auxiliary organ of IDB, has provided US\$ 1 billion on annual basis under the revised Framework Agreement of US\$ 3 billion for three years 2015 – 2017. Under the framework agreement, following three agreements amounting to US\$ 577.00 million were signed during the year 2017-18:-

• On the successful completion of the Framework Agreement (2015-2017), a new Framework Agreement was signed with ITFC on April 05, 2018. Under the new Framework agreement ITFC will make its best effort to mobilize financial resources amounting to US\$ 4.5 billion during the coming three years 2018-2020 (US\$ 1.5 billion on yearly basis.)

#### **OPEC Fund for International Development (OFID):**

- OFID started its operations in August 1976 and became a full-fledged permanent international development agency in May 1980. Its main aim is to foster social and economic progress in the developing world through provision of concessional financing.
- OFID's total Project Portfolio during 2017-18 for Pakistan was US \$ 80 million. Another Loan Agreement amounting to US\$ 50 million for FATA-TDPs Housing Project under Citizen Losses Compensation Program (CLCP) was signed with OFID on 28-06-2017 which was declared effective on 03-10-2017, thus OFID total portfolio increased from US\$ 80 million to US\$ 130 million.

#### **UNITED NATIONS (UN)**

### Approval of Country Programme Document of United Nations Development Programme (UNDP) (2018-2022):

The Country Programme Document (CPD) of United Nations Development Programme (UNDP) was finalized and approved with the UNDP.

### **Approval of Country Programme Document of United Nations Children Fund (UNICEF)** (2018-2022):

The Country Program Document (CPD) of United Nations Children Fund (UNICEF) was finalized and approved with the UNICEF.

#### **Capacity Building of Government of Officers:**

During FY 2017-18, a total number of 26 FTC meetings were held in which 306 courses were decided and 833 officers were nominated to attend trainings abroad.

Economic Affairs Division (EAD), on behalf of the Government of Pakistan, coordinates with the UN System for sustainable economic development and social uplift through efficient, effective and transparent interventions of UN Agencies under the national ownership.

#### Signing of One UN Program (OP-III)/UNSDF (2018-2022):

After the conclusion of (OP-II) in December, 2017, GOP and United Nations Resident Coordination's (UNRC) Office finalized the draft of OP-III. This OP-III document, which is now called as United Nations Sustainable Development Framework (UNSDF) went through several revisions as EAD and RC Office held extensive meetings and deliberation to finalize it and align it with GOP vision 2025. Series of consultations were held with the Federal and Provincial governments as well as UN agencies. The OP-III was signed on 11-04-2018.

#### **Approval of Country Programme Document of World Food Programme:**

The signing of Country Program Document of the World Food Programme between EAD and WFP is under process.

#### World Bank (WB)

EAD also obtained financial and technical assistance from the World Bank Group and International Fund for Agriculture Development (IFAD). The World Bank Group comprises of the International Bank for Reconstruction and Development (IBRD) and its affiliates, the International Development Association (IDA), the International Finance Corporation (IFC), The International Centre for Settlement of Investment Disputes (ICSID), and Multilateral Investment Guarantee Agency (MIGA).

Economic Affairs Division (EAD) and World Bank (WB) have jointly prepared the Country Partnership Strategy (CPS) 2015-19 (now extended upto 2020) which focuses on transforming the energy sector, supporting private sector development, breaking through "good enough" barrier on services, reaching out to the underserved neglected and poor, and leveraging regional markets. Under the CPS, the World Bank has agreed to provide financial support to the tune of US\$ 8.7 billion (approximately US\$ 2.0 billion for IBRD and US\$ 6.7 billion for IDA).

EAD has signed National Transmission Modernization (Phase-I) Project of US\$ 425.00 million, Strengthening Markets for Agriculture and Rural Transformation Project of US\$ 300.00 million, Pakistan Public Financial Management Program of US\$ 400.00 million, Additional Financing of US\$114.0 million for Federally Administered Tribal Areas (FATA) Temporarily Displaced Persons Early Recovery Project, Pakistan Housing Finance Project of US\$ 145.00 million, Additional Financing of US\$ 140.00 million for Sindh Barrages Improvement Project, Punjab Green Program of US\$ 200.00 million, Punjab Cities Program of US\$ 200.00 million and Enhanced Nutrition for Mothers and Children Project of US\$5.00 million (grant) with the World Bank during FY 2017-18. EAD also negotiated Khyber Pass Economic Corridor Project of US\$ 460.6 million, Pakistan Hydromet and DRM Services Project of US\$ 188.00 million, and Sindh Solar Energy Project of US\$ 100.00 million with World Bank during FY 2017-2018. These projects will formally be signed with World Bank in early FY 2019.

In addition to above, EAD also signed seven earlier negotiated projects of US\$. 471.13 million with World Bank during FY 2017-18 i.e. Punjab Tourism for Economic Growth project of US\$ 50.00 million, Financial Inclusion and Infrastructure Project of US\$ 137.00 million, Additional Financing of US\$ 130.00 million for Punjab Irrigated Agriculture Productivity Improvement Program, Sindh Enhanced Response to Reduce Stunting of US\$ 61.70 million, Karachi Neighborhood Improvement Project of US\$ 86.0 million, Strengthening Tax System and

Building Tax Policy Analysis Capacity Project of US\$ 4.90 million (Grant) and Strengthening Debt Management Capacity of US\$ 1.53 million (Grant).

World Bank's commitments for ongoing projects for Pakistan remained at US\$ 7,876.00 million, out of which an amount of US\$ 781.00 million was disbursed by the World Bank during FY 2017-18 (Annex-III). Four projects namely Karachi Port Improvement, Punjab Cities Governance, Sindh Skills Development and Sindh GPE were closed during FY2017-18 with total disbursement of US\$ 27.8 million.

International Finance Corporation (IFC) provides support to private sector development in Pakistan. IFC planned to invest US\$ 3.5 to 4.2 billion in Pakistan. IFC's committed investment exposure (own account) in Pakistan, as of June, 2018 was US\$ 1.30 billion in 41 companies.

The Multi-Donor Trust Fund (MDTF) for KP/FATA and Balochistan was established for restoration of economic and social assets and activities in crisis affected areas by improving local governance and service delivery, provincial economic management capacity and community driven initiatives. Under the Multi Donor Trust Fund (Round-I), being administered by the World Bank, total projects undertaken were of worth US\$ 147.1 million. The MDTF moved onto to Round-II during FY2017 after benefitting approximately 5.7 million people under Round-I. Till date, thirteen contributing partners have pledged US\$ 275.2 million.

Under MDTF Round-II an amount of US\$ 385.69 million would be required (KP 40%, FATA 35% and Balochistan 25%) for growth and job creation, policy reforms and governance & service delivery projects. Currently US\$ 119.0 million are available for MDTF Round-II. EAD has signed three Governance and Policy Programs under MDTF-II at a total cost of US\$ 40.00 million (Balochistan US\$ 16.00 million, FATA US\$ 14.00 million and KP US\$ 10.00 million). Similarly three ongoing projects of Round-I have been extended with Additional Financing of US\$ 31.10 million. The World Bank has disbursed an amount of US\$ 8.51 million during FY2017-18 under ongoing MDTF projects (Annex-III-A).

A Trust Fund for Accelerating Growth and Reforms (TAGR) has been established in the World Bank to support the government's economic reform program by filling knowledge gaps, strengthening the capacity of key institutions – federal and provincial – to complete the design and implement the reform agenda, and building dialogue and consensus. Initially, the Fund

established with a main component including four implementing reform windows, grouped around the four key reform priorities of the Government: (i) Energy sector reforms, (ii) State-owned enterprises and private sector reforms, (iii) Tax reforms, and (iv) Public debt management reforms. Other windows may also be established through which priority reforms could be financed. The total budget for TAGR is £ 24.63 million (approximately \$30.20 million) – a reduction from the initial estimates of £ 30.0 million pledged by DFID. The received amount has been assigned to the four pillars/programs of the Trust Fund, including World Bank and Recipient executed activities. An amount of US\$ 6.4 million is assigned for recipient executed activities to aid Pakistan Debt Management Support Program and State Owned Enterprises (SOE) Reforms and Privatization.

#### **International Fund for Agricultural Development (IFAD)**

The International Fund for Agricultural Development (IFAD) is a membership based international financial institution with a mandate focused exclusively on eradicating rural poverty through low-interest loans and grants. IFAD works with governments to develop and finance programmes that enable the rural poor people to overcome poverty. IFAD operations in Pakistan are guided by the government's strategies and initiatives for rural poverty reduction and an IFAD Country Strategy called Country Strategic Opportunities Program (COSOP). Pakistan being one of the founding members of IFAD had pledged US\$ 9.00 million for 11<sup>th</sup> Replenishment. Presently total commitment from IFAD for Pakistan is US\$ 220.0 million out of which an amount of US\$ 15.45 million was disbursed by IFAD during 2017-18 (Annex-III-B).

# ECONOMIC COOPERATION WITH DEVELOPING COUNTRIES

#### **ECONOMIC COOPERATION (EC)**

Economic Affairs Division is dealing with the Bilateral Economic Cooperation, which is mainly undertaken through an Institutional mechanism in the form of Joint Ministerial Commissions (JMC), Joint Economic Commissions (JEC) and Joint Commissions (JC). EAD coordinates the development assistance from the Gulf Region (Saudi Arabia, Oman, Abu Dhabi, Kuwait) as well as from Economic Development Cooperation Fund (EDCF) of the Republic of Korea. EAD also administers Pakistan Technical Assistance Programme (PTAP), which provides long-term educational facilities and short term training in various fields to more than fifty friendly developing countries.

#### JMC Held:

- ➤ Inaugural session of Pakistan-Senegal Joint Ministerial Commission (JMC) was held on 20-21 July, 2017 in Dakar, Senegal.
- ➤ Fifth Session of Pakistan-Belarus Joint Ministerial Commission (JMC) was held on 16-17 November, 2017 in Grodno, Belarus.
- ➤ Ninth Session of Pakistan-Tunisia Joint Commission (JC) was held on 14-15 February, 2018 in Tunis, Tunisia

#### **Major Achievements:**

- ➤ The Federal Cabinet approved EAD's proposal on 24<sup>th</sup> August, 2017 for Ratification of the signed Agreement on Economic Cooperation between Pakistan and Hungary.
- ➤ The Federal Cabinet approved EAD's proposal on 5<sup>th</sup> December, 2017 for signing of the Agreement on Economic Cooperation for the establishment of Joint Commission between Pakistan and Czech Republic.
- ➤ The Federal Cabinet approved EAD's proposal on 21<sup>st</sup> March, 2018 for signing of the Memorandum of Understanding for the Establishment of Joint Commission on Economic Cooperation with Tanzania.
- ➤ The Federal Cabinet approved EAD's proposal on 21<sup>st</sup> March, 2018 for signing of the Agreement for the establishment of Joint Commission with South Africa.
- ➤ The Federal Cabinet approved EAD's proposal on 17<sup>th</sup> May, 2018 for signing of the Agreement on Technical Cooperation between Pakistan and Brazil.
- ➤ The Federal Cabinet approved EAD's proposal on 17<sup>th</sup> May, 2018 for signing the Agreement for provision of Grant facility amounting to US\$ 14 million to Somalia.

- ➤ Government of Egypt offered short term training courses in food security, rural development, agriculture, and tuberculosis. Ten professionals from various departments/provinces have attended these trainings.
- ➤ The first tranche of US\$ 5 cash grant has been received from Government of Turkey on 30<sup>th</sup> November, 2017, which is expected to be disbursed shortly to TDPs of FATA and flood affectees of Punjab.
- The second tranche of US\$ 5 million has been received on 7<sup>th</sup> June, 2018. EAD has moved a note for Minister for Finance for giving US\$ 2.5 million each to Government of the Punjab and TDP-ERP, EAD.
- A Supplementary Loan for the financing of the Golen Gol Hydropower Project and amendment of the original Loan Agreement No. 742, dated 21-03-2007 between Kuwait Fund for Arab Economic Development and Government of Pakistan (Economic Affairs Division) amounting to K.D 4.5 million was signed in March, 2018.

#### **Joint Ministerial Commission (JMC):**

- ➤ Eleventh session of Pak-Saudi Joint Ministerial Commission was held on 16-17 January 2018 at Islamabad in Pakistan. Pakistan side co-chair was Minister of Commerce and Textile, Mr. Mohammad Pervaiz Malik while the Saudi side was headed by His Excellency the Minister of Commerce and Investment, Dr. Majid bin Abdullah Alkasabi.
- During the session both sides agreed to enhance cooperation in the field of trade and investment, education, health, sports, tourism and heritage, agriculture and veterinary, energy, gas, petroleum, civil aviation, customs, media, Islamic affairs, culture, security and consular cooperation.

#### Pakistan and Saudi Fund for Development Missions/Delegations:

- A Saudi Fund for Development mission visited Pakistan to visit sites of project "Gravity Flow Water Supply Scheme, Mansehra, KPK, w.e.f July 3-7, 2017. Loan Draft Agreement for the project is in final stages and a meeting in Riyadh is scheduled in the early 2019 to review the draft agreement.
- ➤ A Follow-up Mission from Saudi Fund for Development (SFD) visited Pakistan w.e.f. October 31, 2017 to November 3, 2017 to follow up the progress of SFD funded ERRA projects.

- A Pakistani delegation/mission visited Riyadh, Kingdom of Saudi Arabia, w.e.f. 7-11 February, 2018 for loan negotiation of project "Lohar Gali Road Tunnel on Abbottabad-Muzaffarabad Road, Azad Jammu & Kashmir" Loan Draft Agreement is in final stages for negotiations and subsequent signing.
- > SFD funded projects disbursement during FY 2017-18 is US\$ 80.84 million details at (Annex-IV)

#### JMC / JECs:

- Fourth (4<sup>th</sup>) Session of Pak-Vietnam Joint Ministerial Commission (JMC) was held on 3<sup>rd</sup> October, 2017 in Islamabad. Mr. Arif Ahmed Khan, the then Secretary, Economic Affairs Division led the Pakistan side and H.E. Mr. Cao Quoc Hung, Vice Minister, Ministry of Industry and Trade chaired the Viet Nam side.
- Inaugural Session of Pakistan-Philippines Joint Economic Commission (JEC) held on 27-28 February, 2018 in Islamabad. Mr. Arif Ahmed Khan, the then Secretary, Economic Affairs Division led the Pakistan side while Dr. Ceferino S. Rodolfo, Undersecretary, Department of Trade and Industry, led the Philippine side.

#### **Country Programme Mission of Korea:**

A four member delegation from EXIM Bank, Korea visited Pakistan in the month of November, 2017 for Country Programme Mission for Pakistan Economic Development Cooperation Fund (EDCF) to finalize Pipeline Projects to be financed by Exim Bank Korea through EDCF loan for year 2018-2020.

#### **Technical Assistance:**

Pakistan regularly receives offers for technical assistance for capacity building of the Government employees in the form of short term and long term training courses, workshops and seminars. The EAD circulates these offers to relevant Federal and Provincial agencies and also posts them on its website. The position of training / scholarships availed during 2017-18 (July, 2017 to June, 2018) are tabulated below:

#### JMCs Held:

Fifth Session of the Pakistan-Turkmenistan Joint Intergovernmental Commission (JIC) was held on 17-18 August, 2017 at Ashgabat, Turkmenistan. Mr. Khawaja Muhammad Asif Minister for Foreign Affairs was the Co- Chair from Pakistani side and Mr. Rashid Meredov, Deputy Chairman of the Cabinet of Ministers, Minister of Foreign Affairs was the Co- Chair from Turkmenistan's side.

#### **Omani Grant:**

Development Projects in Balochistan Dist. Gawadar and New Gwadar International Air Port (New Gwadar International (Infrastructure) under Omani Grant area being successfully executed. During, FY 2017-18, Amount of US\$ 2.7306 mil was disbursed for these projects.

#### A. Long Term Program of PTAP (Students Admissions):

- Under the long term program of PTAP, 332 students from developing countries and Pak-Origin were granted admissions in MBBS, BDS, D-Pharmacy and B.Sc Engineering against the total 387 reserved seats.
- An amount of Rs.2.2 million was spent on granting scholarships to students of friendly developing countries.

#### **B.** Short Term Component of PTAP (Trainings for Developing Countries):

• Under the short term component of PTAP, 03 trainings were held in the fields of Banking, Railway and Postal Services and a total of 52 participants from Developing countries attended these trainings.

#### C. Colombo Plan and Colombo Plan Staff College Fee:

• Payment of Rs. 2.1 million was made as an annual membership fee towards Colombo Plan Bureau whereas Rs.8.75 million was paid to Colombo Plan Staff College, Manila, Philippines, as annual membership fee.

#### D. Short Term Trainings Offered by Colombo Plan:

 Against four training programs offered by Colombo Plan, a total of 12 officers were nominated in the year 2017-18 in the fields of Indian Technical and Economic Cooperation (ITEC), Eco-Tourism Development, Waste Management and Renewable Energy, and Development of Small and Medium Industry, etc.

# **RESEARCH & STATISTICS**

#### RESEARCH AND STATISTICS (R&S)

Many developing countries including Pakistan do not have sufficient funds to provide public goods such as education, health, transportation, clean water or waste disposal facilities. Although such goods are essential for socio-economic development, their economic rate of return is so uncertain that private investors are unwilling to provide them on a large scale. Foreign aid can substitute for private capital in those instances, providing the funds for investment in public goods that the international capital market either will not supply to Pakistan or would supply at a high interest rate. In principle foreign aid could be a major source of capital, fueling the Pakistan's economic growth and helping to promote socio-economic and human development.

Our major development partners such as World Bank, Asian Development Bank, Islamic Development Bank, China, Japan, and France are providing Foreign Economic Assistance (FEA) in the form for project and non-project aid. Details of FEA provided during the FY 2017-18 are as under.


#### Aid Inflow:

Substantial aid inflows i.e. commitments and disbursements of foreign economic assistance took place during FY 2017-18. EAD maintains systematic record of commitments and disbursements in the shape of "Status Report on Commitments and Disbursements of Foreign Economic Assistance". It is prepared on quarterly basis and is designed to satisfy the diverse needs of different stakeholders. The detail of amount committed and disbursed during the FY 2017-18 is given below:

#### **Commitments:**


**Figure 1 Type of Aid of Commitments:**

Total commitments of foreign economic assistance by the various donors amounted to US\$ 10,738 million during FY 2017-18. It includes Grants amounting to US\$ 84 million and Loans amounting to US\$ 10,654 million (see Figure 1).

#### **Source-Wise Commitments:**

During the FY 2017-18 commitments from mulilateral sources were higher than that of the bilateral sources. Bilateral sources committed an amount of US\$ 254 million while commitments from multilateral sources were US\$ 3,837 million. Similarly, US\$ 2,500 were committed for bonds and US\$ 4,147 million by commercial banks during the period under review (see Figure 2).

Commitments of US\$ 3,837 million from the multilateral sources consisted of US\$ 37 million grants and US\$ 3,800 million loans. Within the multilateral group, World Bank with commitments of US\$ 1,832 million was the largest contributor (see Figure 3). Other major contributors were ADB [US\$ 1,509 million] and IDB [US\$ 412 million]. Commitments of US\$

254 million from the bilateral sources consisted of US\$ 47 million grants and US\$ 207 million loans. Within the bilateral group, France with commitments of US\$ 192 million was the largest donor. Other donors were Japan [US\$ 26 million], China [US\$ 21 million] and Kuwait [US\$ 15 million].

#### **Project Vs Non-Project Commitments:**

Total disbursements of foreign economic assistance amounted to US\$ 11,486 million during FY 2017-18 including Grants of US\$ 569 million and Loans of US\$ 10,917 million (see Figure 5).



#### **Source-Wise Disbursements:**


Disbursements from multiletral sources were higher than that from the bilateral sources (see Figure 6). Share of multilateral and bilateral sources was 25% and 21% respectively in the total disbursements. Bonds and commercial banks contributed 22% and 32% respectively of the total disbursement. 17% disbursements from the bilateral sources came in the shape of grants while 83% were from loans. Disbursements from the multilateral sources were also dominated by loans which were about 94% of total disbursements from multilateral sources.




Figure 7 Project vs Non-Project Disbursements:

Multilateral agencies disbursing over US\$ 500 million each were ADB ,World Bank and IDB (see Figure 7). They contributed about 98% of total disbursements of the multilateral sources. Similarly, within the bilateral group, major disbursements were from China [US\$ 1,811 million], UK [US\$ 198 million], USA [US\$ 117 million], Japan [US\$96 million] and Saudi Arabia [US\$ 68 million]. They contributed more than 96% of total disbursements of the bilateral sources

#### **Project vs Non Project Disbursements:**

Disbursements of Non Project Aid were higher than that of the Project Aid (see Figure 8). Disbursement of Non-Project Aid and Project Aid amounted to US\$7,632million and US\$ 3,855 million respectively.

#### **Higher Forum Meetings:**

During the FY 2017-18 EAD participated in various higher forum meetings. Details are as under:

#### a. Central Development Working Party (CDWP):

Six meetings of CDWP were held during this period. One hundred & nineteen foreign aided projects were approved by the CDWP.

#### b. Executive Committee of the National Economic Council (ECNEC):

Ten meetings of ECNEC were held during this period. Thirty One foreign funded projects were approved by the forum.

#### c. PC-Is & PC-IIs received from Planning Commission:

Three hundred & Sixty Four PC-Is/PC-IIs were received from Planning Commission during the period. Fifty one PC-Is & PC-IIs were concerned with EAD due to involvement of foreign funding which were forwarded to concerned Wings of EAD for their consideration.

#### d. Economic Coordination Committee of the Cabinet (ECC):

Twenty two meetings of the ECC were held during this period. Five items pertained to EAD out of which decisions of four items have been implemented and one is under implementation.

#### e. National Economic Council (NEC):

Two meeting of NEC was held during the period, four items pertained to EAD which have been implemented.

# DEBT MANAGEMENT

#### **DEBT SERVICING**

EAD is responsible for making timely debt-servicing (principal repayments and interest payments) of foreign loans. Actual debt servicing of foreign loans during financial year 2017-18 amounted to \$ 5,811 million, comprising \$ 5,681 million central loans and \$ 130 million guaranteed loans. Central loans were about 97.76% of the total debt servicing of external loans. Debt-servicing of central loans amounted to \$ 5,811 million, comprising \$ 4,106 million principal repayment and \$ 1,575 million interest payments. About 23.35% (\$ 1,357 million) of the total debt-servicing went to the bilateral creditors and 61.21% (3,557 million) to the Multilateral Creditors. About 84.56% (4,913 million) was against the Medium & Long-Term loans while 15.44% (897 million) was against the Short-Term loans. A summarized view of the total debt-servicing (Central + Guaranteed) is tabulated below, while details are at (Annex-VI).

#### **COMPUTER CENTRE**

The Computer Centre (CC) is responsible for maintaining an up-to-date data bank of foreign aid [loans/grants]. Maintaining such a database by recording and analysis of all loans/grants transactions needs a user friendly Management Information System [MIS]. The EAD has been using DMFAS 5.3 for the purpose.

Functions of the CC are of two types:

## INTERNATIONAL DEVELOPMENT ASSISTANCE (IDA)

#### INTERNATIONAL DEVELOPMENT ASSISTANCE (IDA)

After the 18<sup>th</sup> amendment in the Constitution of Pakistan, following functions of the devolved subjects are currently handled by the Economic Affairs Division:

- Dealings and agreements with other countries and international organizations in the fields of health and drugs.
- Scholarships and fellowships, training courses in health from international agencies such as WHO and UNICEF.
- International organizations and agreements relating to Tourism.

The following MoUs / Agreements in the field of Health and Tourism are under process;

- MoU between Pakistan and South Africa in the field of Health.
- MoU between Pakistan and Mauritius in the field of health and medicine.


