2. The objectives and eligibility criteria of the course are as under:

Objectives:

- To provide the participants on knowledge of CVE with a special focus on understanding the terrorist narratives and effort to counter those narratives.
- To showcase Malaysia's efforts in counter-messaging utilising the online media platform and offline engagement.
- To provide the participants with the tools and hands-on experience in developing effective digital counter-narratives content.

Eligibility Criteria:

To be eligible to apply, applicants of the course are obliged to fulfil the following requirements:


- Permanent Government Officers (BS-17 and above) nominated by respective Federal/ Provincial Government
- Must be between the ages of 26 – 46 years at the commencement of the course;
- Must possess a university degree;
- Fluency in both spoken and written English;
- Medically fit (applicants must submit his/her medical report together with the application form).

3. Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority alongwith following documents may be forwarded to this Division by **12th June, 2020 (Friday)** positively.
