Syed Yusuf Raza Gilani Prime Minister of Islamic Republic of Pakistan

Syed Yusuf Raza Gilani took oath of the office of the Prime Minister of Pakistan on March 25, 2008 as the country's 22nd Prime Minister. Syed Yusuf Raza Gilani began his political career in 1978 as member of the Central Working Committee of a leading political party PML. He served as Federal Minister for Housing and Works and later for Railways between 1985 and 1986, and Minister for Tourism and later Housing and Works till 1990. He took oath of the office of Minister for Local Government and Rural Development in 1993 during the interim government.



He was elected as Speaker of the National Assembly of Pakistan in 1993 and held this responsibility up to 1997. He graduated from the renowned Government College, Lahore and got his Masters degree in Journalism from the Punjab University.

Mr. Andrew Mitchell Member of Parliament for Sutton Coldfield, Secretary of State for International Development

Mr. Andrew Mitchell MP, and Secretary of State for International Development, is an experienced and highly effective MP and Government Minister. He was the Member of Parliament for Gedling from 1987 to 1997. During this period he held office as a Government Whip and as Minister for Social Security. He also served as a Vice-Chairman of the Conservative Party from 1992 to 1993. In 2001 he was re-elected to Parliament as MP for Sutton Coldfield. In November 2003, he was appointed Shadow Minister for Economic Affairs. From September 2004 until the end



of the Parliamentary term, he was Shadow Minister for Home Affairs. Following the General Election in May 2005, Mr. Andrew was appointed Shadow Secretary of State for International Development and Secretary of State for International Development following the 2010 General Election.

Mr. Richard C. Holbrooke US Special Representative for Afghanistan and Pakistan

Richard C. Holbrooke is the U.S. Special Representative for Afghanistan and Pakistan. He served as the United States Ambassador to the United Nations, where he was also a member of President Clinton's cabinet (1999-2001). He served as President Clinton's Special Envoy to Bosnia and Kosovo and Special Envoy to Cyprus on a pro-bono basis while a private citizen. From 1993-1994, he was the US Ambassador to Germany. During the Carter Administration (1977-1981), he served as the Assistant Secretary of State for East Asian and



Pacific Affairs, and was in charge of U.S. relations with China at the time Sino-American relations were normalized in December of 1978.

He has received over twenty honorary degrees and numerous awards, including several Nobel Peace Prize nominations. He was Director Emeritus of The Africa-America Institute, was on the Advisory Board of MEMRI, was a Fellow of the American Academy of Arts and Sciences, and formerly a member of the U.S. Board of Governors of Interpeace, and a former Professor-at-Large, Brown University.

Ms. Isabel Guerrero Vice President, World Bank

Ms. Isabel Guerrero is World Bank's Vice President for the South Asia Region since July 2008. She has held management positions in various countries and regions since joining the Bank in 1982. She ran again in 2003 and was elected for the first time.
