- Contract Employees are not eligible

- 3. Nominations of suitable candidates fulfilling the eligibility criteria duly approved by the competent authority shall be forwarded to this Ministry by 1<sup>st</sup> August, 2023 positively. Following points must be considered while nominating the candidates:
  - a. Most relevant candidates should be nominated for the subject training programmes.
  - b. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the EADs' deadline will not be entertained.
  - c. Nomination papers complete in all respect may be forwarded to MoEA through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.

- (3) Introduction to the current development status of China's aviation industry and the main models of civil aviation: Introduction to the history of China's aviation industry since the establishment of the People's Republic of China, including the Y10, Y7, MA series, ARJ21, C919, and various helicopter platforms. The winding path from imitation to independent development has given students a new understanding of the development level of China's civil aviation manufacturing and industry since the founding of the People's Republic of China;
- (4) Efficient operational control of airlines: understanding the airline's operational system, operational control policies, and operational control center (AOC);
- (5) Aviation company safety operation management system: Understand China's latest safety management system, latest system design, supervision and monitoring functions, and reduce the occurrence of unsafe incidents.
- (6) Integrated management of airline fleets: Assist developing countries in planning their fleets and achieving optimization through courses such as safety operations and route network management.
- (7) Mature practices and product introduction of civil aviation emergency management: Establish a preliminary understanding of aviation emergency rescue, and introduce relevant products such as Y12, AC313, etc.
- (8) Air traffic control equipment: understand the role of management systems, communication systems, navigation systems, and monitoring systems in ensuring the route;
