

2. The eligibility criteria and objectives of the subject course are as under:
- Permanent Government Officer (BS-17 & above) of the relevant departments nominated by respective provincial government/ ministry/ organization.
 - Proficiency in English Language.
 - An Agricultural academic background, where priority should be awarded to those who have 3-year experience or more in the relevant field.
 - Submit Medical Certificate certify that the candidate is medically fit and free from infectious & viral disease and HIV disease.
 - A written report is to be prepared and submitted during the first week of the training course focusing on the work nature, and the field-related problems.
 - It's preferable for a candidate not to exceed the age of 40 years, the additional nominee could be accepted up to 45 years.
 - Participants will bear cost of the return trip if, for any reason, they wish to return to their country before the conclusion of the training course.
 - The nominating authority should clearly identify the principal and additional candidates.
 - Fully funded seat, expenses will be borne by sponsoring government, however, for partially funded seat, return Air ticket charges will be borne by the candidate himself/ herself.

3. Nominations of suitable candidates fulfilling the eligibility criteria and duly approved by the competent authority along with the following documents may kindly be forwarded to MoEA:
