Participants are expected to be actively involved in GRACE Project in various ways committed and mandated to contribute to the implementation of the GRACE project as key counterparts.

> Participants are expected to remain in the same position until the end of GRACE Project, that is February 2026 (Persons who will retire or be transferred soon are not eligible to be

nominated.)

- ➤ Ideally, at least 1 female member from the provincial level (Karachi) and at least 1 female member from the district level (Sukkur or Khairpur) will participate in case of 8 participants (in case of 5 participants, having 1 female from Karachi and 0-1 female from district level will be preferred).
