Program Objective

The objective of the Core Human Resource Development for Road Asset Management is to foster young leaders who will contribute to road asset management in developing countries.

Eligibility Criteria:-

The applicant should:

- i. Age less than forty (40) years of age (as of April 1st, 2023)
 - ii. Educational background
 - a. **For Master Degree Course:**
 - At least 16 years of academic background or equivalent
 - A Bachelor's degree
 - b. **For Doctorate Degree Course:**
 - At least 18 years of academic background or equivalent
 - A Master's degree
 - iii. Have 2-3 years of working experience of road asset management sector
 - iv. Have a competent command of spoken and written English
 - v. Management sector in their home countries as well as strengthen the linkage between their countries and Japan after returning home.
 - vi. Be in good health both physically and mentally to participate in the program in Japan
