
Eligibility Criteria:-

- Administrative officials of senior technical staff engaged water supply distribution and service in the government who will continue working in the same field after the course.
- Be university graduates or equivalent
- Have more than 5 years engagement in the field of "Water Distribution and Service" of operations and maintenance of urban water supply.
- Have a strong commitment and capacity to disseminate acquired techniques and knowledge after return.
- Have a satisfactory command of spoken and written English.
- Must be in good health, both physically and mentally.
- Be between the age of twenty-five (25) and fifty (50) years.
